## DEMOCRACY IS BEAUTIFUL

FROM THE DESK OF THE GM

WHEN I FIRST STARTED WORKING IN COOPS I HAD NO IDEA HOW DRASTICALLY
DIFFERENT THEIR STRUCTURE WAS FROM
OTHER RETAILERS. I knew that I was passionate about natural foods, having worked for a privately
owned store when I was in college, but had very little
understanding of what community ownership meant
or what eventually it was going to mean to me. Having
immersed myself in the cooperative world for the past
sixteen years, I now come to regard democratic member control as the crucial aspect of our business that
makes me the most hopeful for a bright future.

So where did this concept that is so integral to the cooperative model originate from? In 1844 in Rochdale, England a group of 28 weavers and artisans came together to form the Rochdale Equitable Pioneers Society. These visionary individuals organized themselves cooperatively and their values and principles have been embraced worldwide by the cooperative community. Among their original organizing documents was this rule of conduct:

"That the principle of 'one member one vote' should obtain in government and the equality of the sexes in membership."

The spirit of this original rule was revised in 1995 by the International Cooperative Alliance in what has become known as the 2nd Cooperative Principle: Democratic Member Control.

This principle states that:

"Co-operatives are democratic organizations controlled by their members, who actively participate in setting their policies and making decisions. Men and women serving as elected representatives are accountable to the membership. In primary co-operatives ....continued on page 2...

members have equal voting rights (one member, one vote), and co-operatives at other levels are also organized in a democratic manner."

The Pioneers were facing severe economic hardships and banded together to meet their basic needs in a way that was just and equitable for all who chose to participate. Their success was hard fought and has stood as a testament to the power that individuals have to control their own collective destiny.

Even with that admirable foundation, anyone who has been associated with a cooperative for a period of time can attest to the turbulence that comes from democratic control of a business. It is not easy to consider the hopes and aspirations of thousands of individuals when making decisions, and for elected directors that difficulty is real and present every month when they come together to govern. In recent years there have been stories of cooperative boards being taken over by owners incensed by the direction that their cooperative is going, oftentimes leading to board officers or co-op management being overthrown. Conversely, an inactive owner community can lead to stagnation in the board, in the management, and in the cooperative as a whole. Though either outcome would be certainly disruptive and is arguably not in the best interest of the cooperative as a whole, it is completely within the purview of the owners to decide their own fate.

So how then do we protect the beauty of our cooperative democracy? We stay active. We take part in board elections, bylaw revisions, and owner discussions. We choose wisely when electing representatives and seek out candidates who match our ideals and values and who are committed to doing the work of the board. We engage each other and our community to ensure that the Co-op is working to meet the common needs of the owners and we speak up when we feel the association is falling short of its ends. We support our elected representatives when they have successes as well as failures, because though the job of a director is often it is extraordinarily vital to the health of our cooperative.

In our recent public discourse, where implications of outside influence have eroded our belief in accurate representation, democracy has gotten a bad rap. It seems as though the will of the people has a hard time making it to the top, which in turn makes people less trusting of their elected officials, which in turn makes people less willing to actively participate. I would like to believe that your co-op exists as an example of the beauty that can happen when voices are heard and representation is authentic. Sure, it is not always the most efficient way to operate an enterprise, but there is elegance in its design. Together we can explore the limitless refinements to that design and as owners craft a democratically governed association that meets the needs of all the people now and in the future.

Democracy is not always pretty in action, but it is remarkably beautiful.

## DEPARTMENT UPDATES

We had a very successful menu relaunch in 2017. Customers have enjoyed the many affordable options on the co-op basics menu. We've sold more grass-fed beef and veggie burgers with our many signature burger offerings. The quicker service and easier-to-navigate menu have been big hits too.

#### **POLY C., DELI MANAGER**

It was a good year in the cheese department with 6.2% growth. We made new partnerships with local creameries, North Branch and Crooked Face. The meat department sold a total of 6,694 lbs of co-op made sausages and 2,945 units of our newest Co-op Basics product, Thousand Hills grass-fed ground beef. 4,086 local Pemaquid oysters were sold in 2017.

In March we welcomed aboard Kyle K. and in June of last year Joe F. celebrated 4 years with the Belfast Co-op. It was a blast last year and we are going to continue growing into 2018!

#### **ALEX C., MEAT & CHEESE MANAGER**

The produce department underwent major changes over the summer, saying goodbye to Sofia, Rurik and crew and bringing on board Michael and Ashleigh, as well as a great team of produce clerks. The department has experienced significant growth, and we're focused on heading into 2018 keeping our relationships with local growers strong and our service to you excellent.

Our goal is to become and remain the best produce department in Waldo County, with abundant displays of local and organic fruits and vegetables and prices everyone can afford. We're looking forward to what's in store for 2018.

#### **MICHAEL W., PRODUCE MANAGER**

Center Store had an exciting 2017, full of change! March kicked off three months of resets. Staff spent many long overnights every few weeks demolishing old shelves, scrubbing old floors, building new shelving units and resetting product. Bread was the last change of the year finally getting its new shelving just before Thanksgiving. We got a fun new addition to our department mid-June when we brought in Aqua ViTea kombucha on tap. We're not done making Center Store the best it can be, so stay tuned for more improvements this year as well.

Outside of the store we extended the concrete receiving pad for more efficient and safe use of the forklift and resealed the parking lot to mitigate cracks. Inside the store we installed new flooring, continued to transition much of our lighting to LED and remodeled the bathroom.
